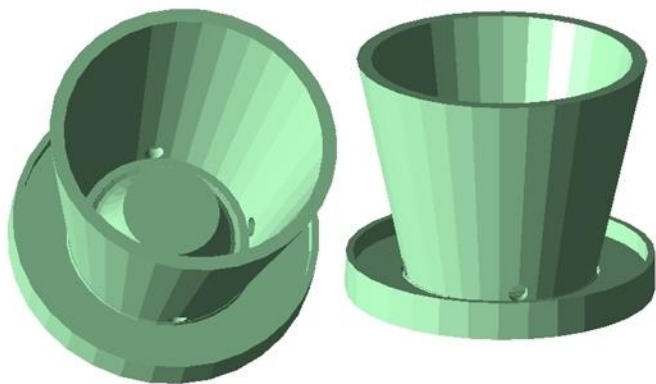

- \* Use the Fast Grow Starter Pot under its intended purposes only, as described in this manual. Do not attach any components that are not specifically made for this product.
- \* Keep away from metal.
- \* Keep away from electrical equipment.

## ■ PLANT HEALTH BENEFITS

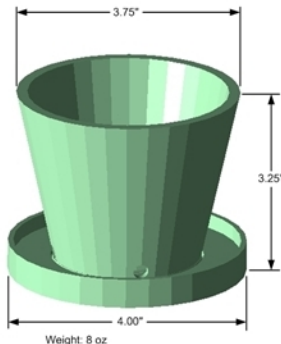
- \* Grows plants up to 50% faster with greater yield in less time.

## ■ MAINTENANCE

1. Do not store near intense heat or an open flame.

Plant seed in the Starter Pot. Add soil and water, and within days, the seeds will sprout. Continue watering as recommended. Each Starter Pot is safe to handle and hermetically sealed in a water-tight food-grade FDA approved material.



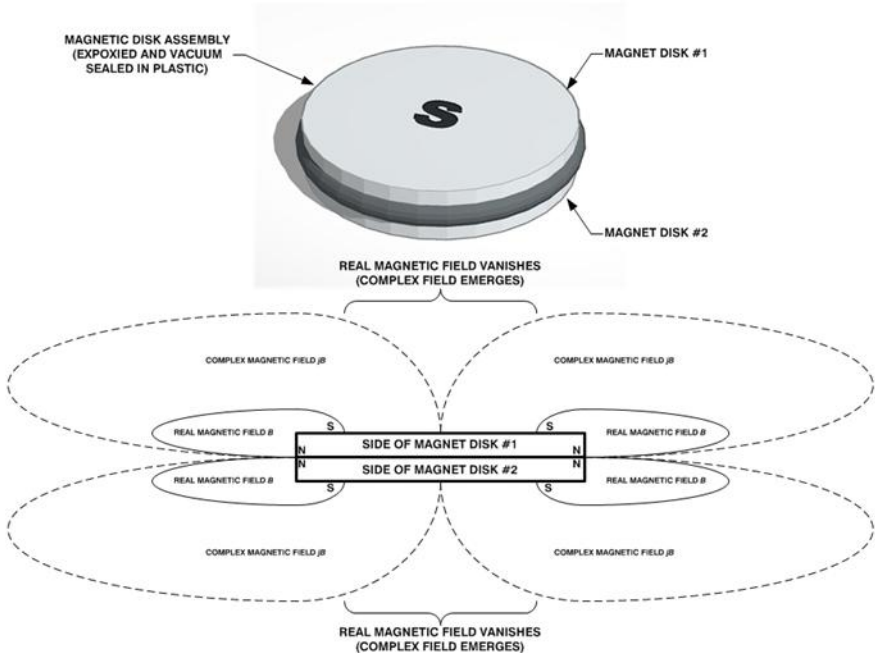

## CONSUMER LIMITED WARRANTY

This warranty guarantees the Fast Grow Starter Pot is to be free from defects in material and workmanship under normal usage for a period of FIVE (5) years. This warranty expires in FIVE (5) years on parts, and ONE (1) year on labor after the date of purchase marked on the Packing Slip.

In the case of defeats in material or workmanship, AuroraTek (referred to as "the Warrantor") will repair this product with the new or rebuilt parts, free of charge in the USA, provided that:

1. It has been operated in accordance to the printed instructions supplied.
2. It has been used under normal conditions, for which it has been designed.
3. It has not been subjected to misuse, negligence or accident.
4. It has received proper care, protection and maintenance.

A purchase receipt, or other proof certifying the date of original purchase, is required fro service and parts replacement under this warranty.

This warranty does not cover damages that occur in shipment, or failures which result from accident, misuse (including, without limitation, failure to comply with instructions and use limitations contained in the Operating Instructions), abuse, neglect, mishandling, faulty installation, setup adjustments, improper operation or maintenance, alteration, modification, commercial use of the product (such as in a hotel, office, restaurant, or other business or rental use of the product), service by anyone other than an the AuroraTek repairman, or damage that is attributable to "Acts of God."

Continued use of the Fast Grow Starter Pot after discovering a defect voids this warranty. This warranty shall be governed by the State of Arizona, United States of America.
